Thank you for your interest in international exchange and for applying for a 2027 States' 4-H Outbound Program! The following document will provide you with step-by-step instructions on using the online application system.

Eligibility & Account Creation

Upon clicking on the application link, you will be taken to an application overview page that provides a brief description of the currently offered Outbound Programs, eligibility requirements, and an ability to “preview” the online application. Click the “Apply” button in the bottom left-hand corner of the screen to begin the application and create your account.

Important Note: Please note that while our national application deadline is December 15, each state may set their own earlier deadline. Please contact your State Coordinator for this state-specific information.

Description

States' 4-H Outbound Programs provides opportunities for international exchange and cultural immersion for 4-H aged youth in the United States. For Summer 2027, States' 4-H offers the following Outbound exchange opportunities:

Please note that the December 15 application deadline is the national application deadline. **For your state's specific application deadline, payment schedule, age range, and program fee, please contact your State Coordinator.**

Requirements

To be eligible to apply for a States' 4-H Outbound Program, applicants must:

- Be 12-18 years old at the time of travel (please note that some programs have varying age ranges, see above chart. Also, some states have separate age requirements -- contact your State Coordinator)
- Be a lawful resident or citizen of the United States
- Reside in one of the following states: AK, AR, AZ, FL, ID, IA, KS, KY, MD, MI, MO, MT, NY, NC, OK, OR, TN, TX, VA, WA

Please note: Program cost does NOT include airfare; this is an additional fee.

Domestic Flight Information

The 2027 Outbound States' 4-H International Exchange Programs begin at the National Departure Orientation at the Gateway City's Airport (where the students will depart and arrive from their international flights). The program ends once the applicant leaves the Gateway City's Airport on their return trip to their home airport. All domestic travel to and from the gateway city is the responsibility of the applicant's parents or guardian.

Parents or guardians of the applicant will be responsible for purchasing and booking domestic flights to and from the gateway city upon the start and end of their program, and be further responsible for the student's travel during that time. There will be no chaperone escort during the domestic flights.

If the applicant is under the age of 15, it is possible the airline may require an Unaccompanied Minor service during their domestic flights. This is dependent on the airline chosen for travel. Parents or guardians will be responsible for setting up and paying for the Unaccompanied Minor service if needed and communicating the applicant's security pin code to States' 4-H for pick-up and drop-off purposes.

International Flight Information

International flights will be booked for applicants by States' 4-H. Applicants will fly with their delegation from the National Departure Orientation at the gateway city to the international country, and will be accompanied by a chaperone at all times. Any applicants that flew as an Unaccompanied Minor on their domestic flight will not require the service on their international flights.

A: Outbound Program Selection

For the Outbound Program Selection, you will select your *top 3* choices for Outbound travel. Please **ONLY** select countries that you are willing to travel to – in other words, if you only are interested in traveling to two Outbound countries, please only select those two countries. In this example, you would just select “none” for your third choice.

If you are interested in traveling to Japan, States' 4-H partners with two different youth organizations in Japan. Please make sure to select either Labo, LEX, or no preference. If you did not rank a Japan program, select "I did not choose a Japan Program."

B: Personal Information

Please complete all questions in the Personal Information section. It is vital that States' 4-H has correct contact information for applicants, their parents/guardians, and an emergency contact. Please ensure that you are inputting your name *exactly* as it is listed in your passport.

C. Health & Allergy Information

We ask all applicants to provide preliminary medical information as part of their application. A sample allergy description is provided below:

For EACH Allergy, please list the following information in the text box below:

1. Type of Allergy
2. Severity of Allergy (1 mild -- 5 severe)
3. Allergic Reaction(s)
4. Medication (name and dosage)
5. Any Additional Info

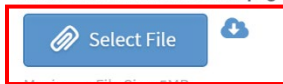

D: Host Family Matching

In this section, you will indicate your host family preferences and whether or not you are applying to be placed with a specific host family. Please note that States' 4-H cannot guarantee that your preferred host family will be available during the exchange, but we will do our best to place you with that family.

The Argentina Exchange Program does *not* have a host family component, so these questions will not apply to that program. However, because most applicants will also rank other exchange programs in their applications, it is requested that ALL applicants complete the host family information questions.

E: Additional Information

This section contains additional questions relating to your travel experience, airport preferences, hosting experience, and foreign language knowledge. Please note that is *not* required to have any foreign language knowledge or travel experience prior to participation on a States' 4-H Outbound Exchange Program.

F: Long Responses

In this section, you will complete the required essays, short-answer questions, and letter to your host family. It is recommended to first type your answers in a separate word document, and then copy/paste them into the application.

TIP: Remember that you can save/exit your application and re-log in if you don't want to finish all the questions at one time!

G: Supplemental Documents

In this section, you will provide photos of yourself and your family, upload a photo of your passport (if you have one), and add any supplemental documents that your state requires.

We ask that you please upload one COLOR headshot (no sunglasses) and two additional COLOR photos of you and your family. You can choose to upload them all as one file, or separately.:
